

Golf Cart Contract and Instructions

Golf carts are for your use within Hacienda Pinilla resort, these are not legal to drive outside of resort premises.

Please keep golf carts on paved roads only, and go SLOW over speed bumps. Going too fast can shake battery cables loose and leave you stranded. Includes no Lola's or Playa Langosta.

If you find yourself stranded, DO NOT attempt to tow golf cart yourself. There is a special setting that if not set, can cause further permanent damage to the carts. Please contact us immediately if stranded via phone or text at numbers above.

<u>Use and Care</u>

Golf carts are stored in the Pura Vida House garage. If you rent golf carts, you will be given a garage door opener for use with the carts.

The key will be found in the cart ignition, and the charging cord will be in the plug. Please always leave the carts charging when not in use; this is better for the batteries, even if the charge light shows full.

Please ensure garage door is closed at all times after entering and exiting, and that the key is in *off* position, and the carts are plugged into charge.

To start the cart, turn the key one click clockwise for on; two clicks right at night will put it in drive with the headlights. (White cart has separate lights button.)

Forward/Reverse switch is on dashboard near the key slot.

Please take the key with you when the cart is parked outside of our garage.

The code for the Las Brisas neighborhood main gate (where our villa is located) is on the keychain – code 565625. There is also a key for the side gate next to the villa, please lock up behind you!

Thank you, and have fun!! Be sure to look all around as you drive through the resort, you will see tons of wildlife, including howler monkeys, iguanas, colorful birds, and more!

- 1. Lessee acknowledges that the Golf Cart is leased by Leaser to Lessee for the use and purpose for which it was manufactured subject, however to the terms and conditions set forth herein.
- 2. Lessee shall return the golf cart to the designated location no later than the date and time specified above or upon Leaser's demand therefore. The golf cart shall be returned in the same condition as when received, ordinary wear accepted.
- 3. Lessee shall pay to Leaser, upon demand, rental for the golf cart at the rate provided until the golf cart is returned to the Leaser. Daily rates will apply if golf cart is kept after the scheduled return date. All days, including weekends and holidays, are chargeable.
- 4. Lessee shall reimburse Leaser, upon demand for the loss of, or any damage to the golf cart or property damage while it is rented to the Lessee and for all costs and expenses incurred by Leaser in collecting and amounts owing by Lessee, including third-party cart rentals while cart is under repair.
- 5. Lessee shall identify and hold Leaser harmless from and against any and all liability, including property damage, bodily injury/death, arising out of the use or operation of the golf cart by Lessee. Lessee is in control of the operation of the golf cart and is aware of its location at all times.
- 6. Lessee shall not assign the Rental Contract or sublease the equipment.

GOLF CARTS RULES

- 1. All Rules and Instructions Listed above are included in contract.
- 2. Lessee of golf cart must be 18 years of age and have in their possession a valid driver's license.
- 3. Never leave the key in the ignition if golf cart is not in use.
- 4. You are responsible for the body condition of the golf cart. (scratches, dents, torn seats, and all other possible damages).
- 5. Golf Carts operated after sunset must have lights turned on.
- 6. Carts must be kept on PAVED ROADS and INSIDE Hacienda Pinilla only; \$50 plus damages will be billed for off-road use or use outside of the resort premises.
- 7. Respect the seat availability. All passengers must be seated while vehicle is in motion
- 8. All repairs must be executed by us.
- 9. Please report any malfunctions on the golf cart immediately, never tow the cart yourself.
- 10. If users do not respect rules and regulations of the golf cart, all rental privileges may be forfeited without refund.
- 11. Driving under the influence of drugs or alcohol is prohibited, all rental privileges will be forfeited without refund.
- 12. You must report to us immediately any accident or stolen cart.

Protection and Security

You agree that if you break any terms of this agreement we can send your personal information to any creditreference agencies, debt collectors, the police or any other relevant organization.

Laws

If there is any contract disagreement or any dispute, this contract agreement contains all the conditions which we have agreed on, and replaces any written or verbal agreements we have with you.

CREDIT CARD AUTHORIZATION

Golf carts may be paid for with cash, check, Venmo or any method listed on our website. However we require credit card authorization in case of damages.
